However, in cases where the candidate(s) anticipate delay in forwarding of 'Through Proper Channel' copy of his/her/their application(s) by his/her/their employer(s) by the closing date indicated at (i) of 'Important Note 'above, then he/she/they may send an 'Advance Copy' of his/her/their application form(s) to the SECRETARY, ASRB, KAB-I, Pusa, New Delhi-110012 on or before the said closing date, failing which his/ her/their candidature(s) for the post(s) concerned will be rejected

without any notice, whatsoever.
