Subject: Result of the Examination held on 17.07.2016 for recruitment to the post of Technical Assistant (T-3) - use of reserve panel for filling up of existing vacancies- reg.

Sir/Madam,

The Agricultural Scientists Recruitment Board (ASRB) is in process of declaring institute-wise result in respect of above cited vacancies for which Open Competitive examination was held on 17.07.2016. As per existing practice, a list of selected candidates as well as a reserve panel is provided by the ASRB. However, after declaration of results, some institutes are soliciting guidance of the Council, as to whether the vacancies arising after conduct of examination, can also be filled up by using the reserve panel.

The matter was examined in light of the instructions contained in DoPT OM No. 41019/18/97-Estt(B) dated 13.06.2000 which *inter-alia* provides that where a selection has been made, a request for nomination from the reserve list, if any, may be made in the event of occurrence of a vacancy caused by non-joining of the candidate(s) within the stipulated time allowed for joining the post or where a candidate joins but he/she resigns or dies. Thus, vacancies which were not included in the



advertisement and/or vacancies arising after declaration of result may not be filled up by using the reserve panel. In other words, only those vacancies, which were advertised for filling up may be filled up by using the reserve panel subject to conditions imposed by DoPT in the above referred OM.

Accordingly, the Competent Authority in the Council has approved the proposal to use the reserve panel (as approved by the ASRB) for the posts of Technical Assistant (T-3) within six months from the date the ASRB conveys to the Institute, the final vetted list of successful candidates alongwith the final reserve list. It is reiterated that the reserve panel is to be used only for the vacancies of Technical Assistant (T-3) for which the advertisement was placed and the examination has been conducted by ASRB and only under conditions of the candidate not joining the post or resigning after joining or he/she dies after joining.

This issues with the approval of the Competent Authority.
