**OFFICE MEMORANDUM**

Subject : **Payment of 2<sup>nd</sup> and Final Instalment of Arrears on account of implementation of 7<sup>th</sup> Central Pay Commission-regarding**

The Competent Authority in the Council has approved the payment of 2<sup>nd</sup> and Final Installment of arrears of Salaries pertaining to implementation of 7<sup>th</sup> Central Pay Commission for Administrative/Technical/Skilled Supporting Staff in ICAR.

2. Accordingly, the 2<sup>nd</sup> installment of salary arrears i.e. remaining 50% of total for Administrative/Technical/Skilled Supporting Staff may be paid immediately from out of the provisions available under Grant-in-Aid Salaries for the units in RE 2017-18.
3. It may be noted that the Arrears may **mandatorily be processed through FMS** and the payment may be made **through PFMS only** viz. the arrears are not to be paid if the same are not being processed through FMS and PFMS.
4. After making the payment of arrears, the units may forward the details, in the enclosed *Annexure (Part A)* to the Council.
5. The additional requirement of funds, , if any, over and above RE 2017-18 allocation for Salaries for making complete payment of Arrears, may also be forwarded to the Budget Section of the Council at [budget.icar@gmail.com](mailto:budget.icar@gmail.com) in *Annexure (Part B)* for consideration
