Subject:- Admissibility to travel by Tejas Express, Vande Bharat Express & Humsafar Express trains under Leave Travel Concession (LTC)-reg.

The undersigned is directed to refer to this Department's O.M. No. 31011/8/2017-Estt.A-IV dated 19.09.2017 regarding admissibility to travel by premium/specific trains under CCS(LTC) Rules, 1988.


2. This department has been receiving a number of references from different offices/individuals about the admissibility of various premium trains like Tejas Express, Vande Bharat Express & Humsafar Express trains under Leave Travel Concession.

3. The matter has been examined by this Department in consultation with Department of Expenditure and it has been decided that apart from existing Rajdhani, Shatabdi and Durgam Chattrapatti trains, travel by **Tejas Express, Vande Bharat Express & Humsafar Express** trains under LTC as per the entitlement of the Government employees, has now been allowed, as under:-

Pay Level in Pay Matrix (as per 7 th Central Pay Commission) of the Central Government employees	Travel Entitlement for LTC in Premium Trains (i.e. Rajdhani, Shatabdi, Durgam Chattrapatti, Vande Bharat Express, Tejas Express, Humsafar Express trains)	
	Shatabdi or Similar type trains	Rajdhani Type or Similar type trains
Level 12 and above	Executive Class	AC 1 st Class
Level 6 to 11	Chair Car	AC 2 nd Class
Level 5 and below	Chair Car	AC 3 rd Class

4. The other terms and conditions of O.M. No. 31011/8/2017-Estt.A-IV dated 19.09.2017 shall remain the same.
