Master's degree of a recognized University or equivalent in any subject with Hindi and English as subjects at the degree level:

OR

Master's degree of a recognized University or equivalent in any subject with Hindi Medium and English as a subject at the degree level;

OR

Master's degree of a recognized University or equivalent in any subject with English Medium and Hindi as a subject at the degree level.

- 1. The general terms and conditions of services at ICAR will be governed as per the Rules and Bye-laws of ICAR.
- 2. The terms of deputation pay and allowances shall be governed by the provisions laid down in the Department of Personnel & Training Office Memorandum No. 6/8/2009- Estt. (Pay II) dated 17 June 2010 and other amendments/orders/guidelines issued in this regard from time to time.
- 3. The period of deputation shall be for 2 years. However, the same can be terminated prematurely upon giving a 3 months' advance notice from both sides.

- 4. The total period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed 3 years.
- 5. The departmental officers in the feeder category, who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.
- 6. The maximum age limit for appointment on deputation shall not be exceeding 58 years as on the closing date of receipt of applications.
- 7. Eligible and willing candidates may apply to the ICAR in prescribed format **Annexure-1** along with **Annexure-II** & enclosures mentioned therein.
- 8. Cadre Controlling authorities/Head of Departments are requested to forward applications of eligible and willing candidates whose services can be spared on deputation immediately on their selection accompanying the following documents so as to reach undersigned latest by **30.11.2022**:
  - A. Attested copy of application in prescribed proforma Annexure I
  - B. Duly Filled **Annexure II**, indicating/enclosing following:
    - i. Cadre Clearance Certificate from the Controlling Authority.
    - ii. Certification that the particulars furnished by the applicant have been verified & are correct.
    - iii. Statement giving detail of Major/Minor penalties, imposed upon the Officer, if any, during the last ten (10) years
    - iv. Vigilance Clearance/ Integrity Certificate.
    - v. Photocopies of the ACRs/APARs for the last five (5) years duly attested on each page by an officer not below the level of Under Secretary or equivalent.
- 9. Applications received after the last date/incomplete application shall not be entertained. Candidates who apply for the post will not be allowed to withdraw their candidature subsequently. ICAR reserves the right not to fill up all or any of the vacancies or to withdraw the circular at any time without assigning any reasons.
