The issue of discipline in fiscal transfers to Autonomous Bodies at Central/State/Local eyel has been discussed in pre-budget meetings held in this Ministry with various Ministries and Departments. In the light of these discussions, it has been decided that Grants-in-aid should not be released to any Autonomous Body or NGO or any other organization/institution (other than State Governments) if it has not submitted all Litilization Certificates (s) (UC) due for rendition, for grants-in-aid released by the Central Government in respect of all of the schemes/programmes/projects of a Ministry/Department of Government of India. This will come into force with immediate effect and any deviation from the same would require specific approval of the Ministry of Finance.
