It has been brought to the notice of the Prime Minister that there have been instances where letters addressed to the Officers by the Members of Parliament (MP) are not acknowledged / replied promptly. In this regard, I would draw your attention to DoPT OM No. 11013/4/2011-Est(A), dated 01.12.2011, which prescribes the observance of proper procedure in official dealings between the administration and MPs.

2. It is reiterated that appropriate steps may be taken to ensure that letters from Members of Parliament and Members of State Legislatures must be properly acknowledged and reply sent at an appropriate level expeditiously as per the relevant provisions of Central Secretariat Manual of Office Procedures, which have been excerpted at para 4 of the DoPT OM dated 01.12.2011.

3. Suitable instructions in this regard may also be issued to all the attached / subordinate offices and public sector undertakings attached to your Ministry / Department.
