SUB: Revised Scheme and Syllabus for Training and Examination of employees of the Indian Council of Agricultural Research in Audit and Accounts Examination.

Sir,

In continuation of Council's letter of even no. dated 18th April, 2013 on the subject cited above and to inform that the Governing Body of ICAR society in its meeting held on 28th June, 2013 has approved the revised scheme and syllabus for Training and Examination of Employees of the Indian Council of Agricultural Research (ICAR) in Audit and Accounts matters.

Further, the Para 5 of Annexure A - Scheme for training and examination of employees of the ICAR in Audit & Accounts matters has been amended as under:

"The qualifying marks for passing shall be an aggregate 45% with not less than 40% marks in each paper. Any candidate who has passed in a particular paper will not be required to repeat that paper provided he/she gets not less than 60% marks in that paper. For the paper – Essay, Precis & Draft - this limit will be 50%. Further, 5% relaxation is provided to SC/ST/Physically Handicapped candidates in qualifying marks i.e. 40% in aggregate and not less than 35% in each paper. However, there will be no change in 60% marks for exemption from appearing in the examination of the paper. For Essay, Precis & Draft the relaxed standard will be 45%".

The revised amendment may be circulated among the staff members for information.
