As you are aware, the Government in order to ensure adequate representation of backward classes of society in services provides reservation to the Scheduled Castes, Scheduled Tribes, Other Backward Classes and also to the persons with disabilities (PWD). It is observed that some vacancies reserved for these categories have remained unfilled. The Government launched a Special Recruitment Drive in November, 2008 to fill up such backlog reserved vacancies of SCs, STs, OBCs, and another Special Recruitment Drive to fill up the backlog reserved vacancies of persons with disabilities in November, 2009.

2. On reviewing the status, I have found that the progress of filling up of the backlog vacancies has not been encouraging so far. The Government is committed to complete the quota of SCs, STs, OBCs and persons with disabilities and launching of the drives is an important step towards fulfillment of this commitment. I, therefore, urge upon you to look into the matter personally and impress upon all appointing authorities under you to take all necessary steps to fill up the backlog reserved vacancies of SCs, STs, OBCs and persons with disabilities on top priority basis.
