SUB: Mandatory publication of tender enquires as well as detail of bid awards on Central Procurement Portal (CPP): Reg.

As per instructions from MOF, a compliance report is required to be submitted by all FAs on mandatory publication of tender enquires as well as detail of bid awards on Central Procurement Portal (CPP) to MOF, Deptt. of Expenditure, New Delhi.

Accordingly, all SMDs were requested vide Council's letter of even no. dated the 24th Jan, 2014 for submission of a compliance report to IFD. Further, time to time reminders were also issued on 7th Aug, 30th Sept, 27th Oct, 5th Nov, 13th Nov and 5th Dec, 2014 and D.O. reminder also from the Secretary, DARE and the DG, ICAR dated 27th Jan, 2015 to concerned DDGs (Agril. Extn., Agril. Engg., Animal Science, Edn, NRM, Fishery and Hort.) and dated 4th Feb, 2015 to DDG (CS) and also further reminders dated 23rd Feb, 9th March and 27th March, 2015 to concerned DDGs (Crop, Hort, Agril. Extn., NRM and Fishery Science). But information regarding compliance has not been received from 29 Institutes (List enclosed) till date. The concerned SMDs (Crop, Hort, Agril. Extn., NRM and Fishery Science) were again reminded on 16th April, 2015 at the level of Director (Fin.). But compliance is still awaited. The matter also came up for discussion in recent SOC held on 30.4.2015.

Accordingly, as per discussion in the SOC, while partial compliance report is being submitted to MOF, its non-compliance by the 29 defaulting Institutes is a matter of very serious concern which was highlighted by the SS & FA, ICAR/DARE. Now, non-compliance shall be the responsibility of Director of defaulting Institutes and concerned DDG also. There is no point left in sending reminders anymore.
