

**CIRCULAR**

In continuation of the circular of even number dated 01.05.2014 notifying the programme for conduct of election of Secretary (staff Side), Central Joint Staff Council (CJSC) by means of postal secret ballot, the terms and conditions governing the election are as under:

1. The nominations can be filled only by elected members of the CJSC who are otherwise eligible to cast vote in the election.
2. Only one nomination form duly filled in all respect shall be submitted by the contesting candidate.
3. The schedule for filling the nominations etc. is as indicated in the Council's circular date 01.05.2014.
4. The candidate who is eligible to cast vote can propose or second only one nominee at one time. In case he/she proposes/seconds more than one nomination, all the nominations proposed or seconded by him/her will stand cancelled. In other words, a member who has the right to cast the vote can sign only one nomination as a proposer or seconder. In no case he/she will be allowed to sign more than one nomination form as proposer or seconder.
5. The counting of ballots will take place in the premises of Krishi Bhavan, New Delhi. The contesting candidates may make their presence at the time of counting, if so desire.
