Reference is invited to instructions issued with respect to "Expenditure Management Economy Measures and Rationalization of Expenditure" by the Department of Expenditure vide their O.M. No. 7(2)/E.Coord/2013 dated 18<sup>th</sup> September, 2013 and subsequent letter conveying the ceilings of Revised Estimates (RE) of expenditure for the current financial year. The above instructions, inter-alia, contained various directions related to maintaining a balanced pace of expenditure, observance of discipline in fiscal transfers to autonomous bodies, PSUs and State Governments and procedures to be observed while releasing advance for procurements of goods and services. It was further directed that rush of expenditure on procurement should be avoided towards the end of financial year, and it must be ensured that necessary financial procedures are complied with before release of funds.

2. As the financial year, 2013-14, draws towards closure, you are advised that various instructions issued by Ministry of Finance are scrupulously followed by all the concerned officials. It may kindly be ensured that <u>RE</u> ceiling conveyed by M/o Finance, and quarterly and monthly ceilings, are strictly adhered to unless specific exemption has been granted. Under no circumstances funds are to be released to autonomous bodies/PSUs with intent to park funds. I shall be grateful if you could kindly issue necessary instructions to all concerned in your Department in this regard.
